SUBJECT: Expansion of catalogue of updated Medical Impairment Assessment (MIA) forms for assessing compensation claims under the MRCA and VEA.

Purpose: To inform CBD staff of an additional eight updated MIA forms that replace the existing forms used when requesting medical evidence for the purpose of assessing compensation claims.

Key Points:

- The Claims Processing Improvement Division (CPID) has continued the review of existing forms and consolidated a further twenty forms. A further eight consolidated forms are now available for use.
